TERMS & CONDITIONS OF TRADE

Should Commercial credit be extended to the Applicant as a result of this application, the Applicant agrees to the following:

1. "The Applicant" understands that the trading terms are sight draft/document on payment unless otherwise agreed in writing.
2. "The Applicant" further understands that should "The Applicant" default in payment of monies due, that all such monies shall become due and payable and shall be paid within seven (7) days from the date of demand.

3. "The Applicant" shall be liable for and shall pay interest at the rate of 1.04% per month (or such rate not to exceed 3.0% per month as Geoffrey Hughes (Export) Pty Limited may at any time and from time to time notify "The Applicant" in writing as being the rate applicable subsequent to the date of any such notice) to date of payment on all amounts which from time to time remain unpaid in excess of 30 days from the original invoice due date which interest shall be calculated on a daily basis and compounded monthly.
4. "The Applicant" further understands that Geoffrey Hughes (Export) Pty Limited reserves the right to withhold the supply of goods and services at any time without notice to "The Applicant".
5. In the event of this application being successful a fixed credit limit will be determined by Geoffrey Hughes (Export) Pty Limited. Should the account balance exceed the limit Geoffrey Hughes (Export) Pty Limited reserves the right to withhold the supply of goods and services without notice.
6. "The Applicant" further understands that Geoffrey Hughes (Export) Pty Limited reserves the right to vary these terms and conditions from time to time and undertakes to notify "The Applicant" of such variations. All orders received after such notice will be deemed to be under the new terms and conditions.
7. "The Applicant" further understands and agrees that should any conditions of "The Applicants" purchase order(s) or in any other subsequent document, purport to vary Geoffrey Hughes (Export) Pty Limited standard terms and conditions the same will not be binding upon Geoffrey Hughes (Export) Pty Limited unless agreed in writing by Geoffrey Hughes (Export) Pty Limited.
8. Title to goods supplied by Geoffrey Hughes (Export) Pty Limited or its agents acting on its behalf will not pass until Geoffrey Hughes (Export) Pty Limited has been paid in full for those goods. "The Applicant" hereby grants to Geoffrey Hughes (Export) Pty Limited an irrevocable licence to enter any premises in which the goods are situated for purpose of repossession if payment is not made, Geoffrey Hughes (Export) Pty Limited is entitled to monies obtained from the proceeds of the sale of goods by "The Applicant" or his/her agent.
9. "The Applicant" agrees and acknowledges that no request to change the name of the account or to operate the account in a different name shall affect or discharge "The Applicant" liability.
10. "The Applicant" shall pay to Geoffrey Hughes (Export) Pty Limited forthwith on demand all costs, charges and expenses as between solicitor and own client incurred by Geoffrey Hughes (Export) Pty Limited enforcing or attempting to enforce all or any of its rights, powers or remedies hereunder or at law or otherwise in connection with collecting or recovering all or any money now or in the future, owing by "The Applicant" to Geoffrey Hughes (Export) Pty Limited with respect to the account.
11. Claims for damages or shortages must be submitted in writing within 48 hours of devanning and are subject to the respective manufacturer/suppliers claim policy.
12. All transactions between "The Applicant" and Geoffrey Hughes (Export) Pty Limited or its agents (the parties) will be governed by the laws of New South Wales, Australia. Unless resolved "The Applicant" and Geoffrey Hughes (Export) Pty Limited and its agents hereby agree to submit to the exclusive jurisdiction of the Supreme Court of New South Wales in relation to any disputes arising between the parties.
